Sir,

Shree Vidyadhiraja Homoeopathic Medical College, Nemom, Thiruvananthapuram- 695020 is functional since 1975 and has applied for permission for sanction of UG (BHMS) course with 63 seats including EWS quota for the academic year 2024-25. The College has submitted the Part I information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the application, the Medical Assessment and Rating Board has observed the following shortfalls as per MSR requirements:

a) Miscellaneous

- College has not enabled the Adhaar Enabled Biometric Attendance system (AEBAS).
- The college has not given information regarding the CCTV surveillance installation.

b) Teaching Faculty

- Only 2 guest faculties have been mentioned in the list against the need of 08 guest faculties.

c) OPD and IPD Department

- Demographic details of patients are not recorded on case sheets. Diagnosis and proper case taking is not done with no follow-ups of the patients. Case records shall be maintained with detailed case history, complete case analysis, evaluation, repertorisation and prescription made available in the medical record room for academic purposes of students and follow up attendance of patients

MISCELLANEOUS

Considering the above observations and facilities available, Medical assessment and Rating board has decided to issue **Conditional Permission to Shree Vidyadhiraja Homoeopathic Medical College, Nemom, Thiruvananthapuram- 695020 for conducting UG (BHMS) course with 63 seats for the academic year 2024-2025.**

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

All admissions shall be made for NEET qualified candidates only. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt

as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.


Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.
